**Nigerian Enterprises Promotion (Designation of Inspectors)**  
(No. 2) Order 1974

*Commencement : 2nd October 1974*

In exercise of the powers conferred by section 6 (1) of the Nigerian Enterprises Promotion Decree 1972 (as amended by the Nigerian Enterprises Promotion (Amendment) Decree 1973), and of all other powers enabling me in that behalf, I, Dr J. E. Adetoro, Federal Commissioner for Industries, hereby make the following Order :—

**Designation of inspectors of enterprises.**
